NEW BUSINESS: Karen Linza made the motion for the Town Supervisor to **sign the Shared Assessor's Agreement**. The motion was **2nd** by Ron Staedt.

Town Supervisors of Alma, Amity, Wellsville, Andover, Friendship and Willing, have been meeting for the last 6 months, creating a Tax Assessor Consortium. The assessor will be available at the Wellsville Tax Assessor's Office 5 days per week from 8am to 4pm. He will have 2 assistants. The cost savings to all of the 6 towns will be equal. Ron Staedt said that initially, the budgeted cost of property parcel assessment was \$12 per parcel. The cost was actually about \$11.50. At the time of revaluation/reassessment, it changed to \$43 per parcel. **With the new agreement, the new assessment rate from now through the 6 year agreement will be \$10.50 per parcel.** There will be a rotation of reassessment for each of the 6 towns over 6 years. **Our scheduled reassessment will be in 4 years and will be \$10.50 per parcel.** Karen Linza made the motion to **appoint Timothy Joseph Dannheim of Wellsville as Tax Assessor for the term of 6 years (October 1st, 2019 to September 30th, 2025).** He was an apprentice for the Northern Tax Assessors Consortium out of Rushford and has the required education and training for the job. We have always shared an assessor with Wellsville but, we have no provisions to afford to set up our own Tax Assessor. He can come here if you'd like to meet him. He is able to operate wherever there is laptop computer connectivity and handicap access.
